- Rehearsal Location: Grafton Softball/Football field COVID-19; Protocols must be followed, students will be required to answer 5-10 questions, wear masks unless playing instrument or drinking water; social distance 6 feet apart, and practice students social distance 10 ft apart, plastic instrument covers; bell covers, etc.
- Band Fees has been reduced to \$75.00; Parents will need to pay the fee through Paypal and expect to include a small fee for processing the payment. Total &76.59. The Color Guard fee is the same.

- Q2. -24 Feb All District Band virtual event; the Army Band will offer sessions and Dr. Tim will do closing session for students.
- Q3.- Kirsch reported that the District has taken everything under advisement regarding Parent Volunteers. They should make a decision soon allow or not allow parents to serve as volunteers during Marching Season. No parents will be allowed at rehearsals.
- Q4.-Update on Uniforms: Students will wear a Band Hoodie/Jeans/Tennis Shoes; no band shoes will be required; the same applies for the Color Guard.

Melissa reported and provided a copy of the Budget with proposed changes to the group. The following changes were recommended:

TAG A Thon income increased; No TAG Day income included; Hoodies/Band Camp/PPE equipment costs; \$5000 has been on uniform reserve; Student Scholarships-13,000 short (A large amount of the fees will be absorbed due to COVID-19 conditions). Our Post Office Box Number has changed to 2132 and reduced to a smaller box/lower fees. Change also will be made on the website. All old mail will be forwarded to the new box for up to one year.
